

Malaysia Competition Commission (MyCC)

The Malaysia Competition Commission (MyCC) is an independent body established under the Competition Commission Act 2010 to enforce the Competition Act 2010. The Competition Act and the Competition Commission Act were gazetted on 10 June 2010 and enforced beginning 1 January 2012. The acts aimed to encourage national economic development by encouraging and protecting the competition process in the market and consequently protecting consumer interests.

Commission's Main Functions

The Competition Commission Act 2010 empowers the Malaysia Competition Commission (MyCC) to carry out functions such as implement and enforce the provisions of the Competition Act 2010, issue guidelines in relation to the implementation and enforcement of the competition laws, act as an advocate for competition matters; carry out general studies in relation to issues connected with competition in the Malaysian economy or particular sectors of the Malaysian economy; inform and educate the public regarding the ways in which competition may benefit consumers in, and the economy of, Malaysia.

The MyCC is inviting dedicated and committed candidates with high integrity and professionals to join us. Please note that applicant must be a MALAYSIAN CITIZEN and the position offered is on a CONTRACT basis:

GENERAL ELIGIBILITY CRITERIA

- 1. Must be a Malaysian citizen; and
- 2. Must be at least 18 years of age as of the closing date of the job advertisement.

QUALIFICATION REQUIREMENT FOR THE MALAY LANGUAGE

 Must possess an excellence (at least Grade C) in the Malay Language subject at the level of the Malaysian Certificate of Education / Malaysian Vocational Certificate, or any qualification duly recognized by the Government.

APPLICATION PROCEDURE

- 1. Applications must be submitted through the official website of the Malaysia Competition Commission (MyCC) at www.mycc.gov.my.
- 2. Each application form must be accompanied by a formal passport-sized photograph and certified copies of the following documents:
 - a. National Identity Card;
 - b. Diploma/Degree along with the Transcripts and a Letter of Degree/Diploma Recognition from the Malaysian Qualifications Agency (MQA) or the Public Services Department (JPA);
 - c. School leaving certificate;
 - d. Certificates such as PMR, SPM, STPM; and
 - e. Other relevant certificates.
- 3. Incomplete or non-compliant application forms will not be considered. As an example, failure to include a photograph will render the application incomplete.
- 4. The salary offered will be determined based on academic qualifications, experience, and other conditions specified by the Government and is non-negotiable. No negotiations will be entertained.
- 5. The application deadline is 20th NOVEMBER 2025.

MANAGEMENT AND PROFESSIONAL GROUP

Degree/Master in Law from recognised university by the Malaysian Government. A
first-level university degree in combination with at least two additional years of
qualifying experience may be accepted in lieu of the advanced university degree;

1. Additional Requirements:

- Strictly for candidate with extensive experience minimum 10 years in in a similar role, preferably in a regulatory agency, government body, or legal/consulting firm specializing in competition law;
- ii. Strong analytical and research skills, with the ability to interpret and synthesize complex information;
- iii. Sound knowledge on competition policy and law or equivalent;
- iv. Knowledge on Government policies would be an added advantage including experience liaising with Government departments and agencies;
- v. Well versed in Government circulars / laws / policies and best practices;
- vi. Excellent writing and communication skills in Bahasa Malaysia and English;
- vii. Exceptional analytical and problem-solving skills;
- viii. Excellent interpersonal skills to deal with all levels of people in the organisation;
- ix. Experienced in supervising a team or be a team lead; AND
- x. Ability to work independently as well as in a team environment.

In addition to the required relevant experience and mass communication knowledge, candidates should portray of the following:

- Committed and dedicated to organizational goals and objectives;
- Strong interpersonal skills such as negotiating, problem-solving, and knowledge-sharing; and
- Ability to work under pressure with the right attitude, strong integrity, upholds teamwork principle, highly resilient with professional character.

Core Responsibilities:

- 1. Responsible for providing and advising on legal issues to ensure compliance with laws and regulations related but not limited to the Federal Constitution, procedures and/or legal ethics;
- 2. Responsible for advising on any proposed amendments to the regulations or legislation related to the Competition Commission or the implementation of the Competition Act 2010;
- 3. Responsible for advising on the jurisdiction and theoretical powers of the Competition Commission. Responsible for preparing answers or comments on the actions of the Competition Commission;
- 4. Responsible for the coordination of any relationship between the Competition Commission and the Attorney General's Chambers as well as the legislature both national and international level;
- 5. Responsible for conducting prosecutions in cases related to competition issues;
- 6. Responsible for attending and advising the Competition Commission in meetings or negotiations at home country and abroad;
- 7. Responsible for representing the Competition Commission in cases related to competition issues at the national or international level;
- 8. Prepare and manage annual division budget; AND
- 9. Perform any ad hoc tasks required by Management / CEO as and when necessary.
