# AANZFTA competition agency heads gather



The CLIP team was delighted to work with the Competition Commission of Singapore (CCS) to support the 1<sup>st</sup> meeting of AANZFTA competition agency heads on 27 May 2016 in the sidelines of this year's **International Competition Network** (ICN) annual meeting in Singapore.

Hosted by Toh Han Li, Chief Executive of the CCS, and Rod Sims, Chairman of the ACCC, the meeting brought together the region's most senior competition officials for a closed door discussion of competition enforcement: opportunities and challenges. This was the first occasion for many to meet new ASEAN colleagues and to take part in an ICN annual meeting.

In chairing the meeting, Anna Wu, Chairperson of the Hong Kong Competition Commission, drew on her own recent experience of setting up a new agency to encourage sharing of views and ideas on what's important when starting out to enforce competition law. Agency heads were candid in their assessments of agency priorities (including capacity building needs) and the constraints they faced in progressing competition in their jurisdictions.

A recurring theme in discussion was the pressing need to build everyday enforcement skills, as well as the importance of garnering political support and funding to grow a competition agency.

#### Train-the-trainer investigations workshop, Malaysia

Recently Dominique from the CLIP team partnered with Adam Jarvis (General Manager of Enforcement for Western Australia and South Australia at the ACCC) and competition law expert Rachel Burgess to customise a train-the-trainer style workshop for colleagues at the Malaysia Competition Commission (MyCC).

The delivery team subsequently spent three days in Kuala Lumpur workshopping human resource development strategies (including ideas for training staff on-the-job) and core content for investigations training. The workshop was attended by 32 participants from the MyCC and sectoral regulators and officials with whom the MyCC interfaces in carrying out its function.

### CLIP in the ASEAN Secretariat

### Australia's first criminal cartel charge laid

Following an ACCC investigation, Nippon Yusen Kabushiki Kaisha (NYK), a global shipping company based in Japan, pleaded guilty on 18 July to criminal cartel conduct in Australia's Federal Court.

"This is the first criminal charge laid against a corporation under the criminal cartel provisions of the Competition and Consumer Act," ACCC Chairman Rod Sims said.

"This matter relates to alleged cartel conduct in connection with the transportation of vehicles, including cars, trucks, and buses, to Australia between July 2009 and September 2012," Mr Sims said.

In Australia, for corporations, the maximum fine for each criminal cartel offence will be the greater of:

- AUD10 million;
- three times the total benefits that have been obtained and are reasonably attributable to the commission of the offence;
- if the total value of the benefits cannot be determined,10% of the corporation's annual turnover connected with Australia.

The ACCC's investigation into other alleged cartel participants is continuing.
